ORDER:

In the G.O. first read above, comprehensive guidelines were issued for implementation of Self Employment Schemes being implemented by Andhra Pradesh Scheduled Castes Cooperative Finance Corporation Ltd., wherein the Selection of beneficiaries shall be done by a Screening-cum-Selection Committee at the Mandal, Municipality and the Municipal Corporation levels, which was subsequently amended by the G.O. in the reference 3rd cited.
- 3. In view of the feedback received in the meetings of the SLBC Sub-Committee by the Social Welfare Department (the Nodal Department for the implementation of the Action Plans of the Finance Corporations of the Welfare Departments) and from the other stakeholders and duly taking into consideration the Action Plans of the SC/ST/BC/Minorities Welfare Departments, and the deliberations held in the reference 4th cited, there is a need to reconstitute the Screening-cum Selection Committees at the Mandal, Municipality and the Municipal Corporation levels in order to make it more representative and functional.
